RE: Support Energy Efficiency, Oppose the Homeowner Energy Freedom Act (H.R. 1603)

Dear Chairwoman McMorris Rodgers and Ranking Member Pallone,

We, the undersigned coalition of over 200 businesses, trade associations, environmental advocates, energy efficiency advocates, contractors, small business owners, and other members of the building performance industry write to **voice our strong opposition to H.R. 1603, the Homeowner Energy Freedom Act** (also known as Sec. 10016 within H.R. 1, the Lower Energy Costs Act). This legislation would repeal and rescind funding for three vital programs included in the Inflation Reduction Act: High-Efficiency Electric Home Rebate Program (HEEHR, Sec. 50122); State-Based Home Energy Efficiency Contractor Training Grants (IRA Sec. 50123); and Assistance for Latest and Zero Building Energy Code Adoption (IRA Sec. 50131).

At a time of volatile energy costs and the need to mitigate carbon emissions, these three programs are critical to improving our nation's energy security and economic growth, while also lowering consumer energy bills. According to the International Energy Agency (IEA), <u>energy efficiency</u> alone has the ability to achieve 40% of the emission reductions required under the Paris Agreement. Moreover, based on data from the <u>Energy Efficiency Impact Report</u>, but for existing energy efficiency investments, carbon emissions would have been 80% higher in 2021. Furthermore, <u>without the energy efficiency</u> investments made since 1980, energy consumption and emissions would have been 77% higher, and consumers would be paying nearly \$800 billion more per year in energy costs. Also, energy efficiency is a major economic engine, equaling <u>2.2 million jobs</u> with <u>75% of the workforce</u> being employed by small businesses with under 20 employees.

HEEHR provides funding to states, tribes, and territories to create programs providing point-of-sale rebates for high-efficiency electric appliance upgrades, insulation, and air sealing. HEEHR is only available to low- and moderate-income households – in other words, those least likely to afford these upgrades. **State-Based Contractor Training Grants** provide grants to states and territories to expand America's home performance and electrification workforce, financing critical on-the-job training via wage subsidies and online and in-person certification and testing. At a time of critical workforce shortages, this important funding will help small businesses train crews to help homeowners cost-effectively upgrade their homes. ¹ **Building Energy Code Adoption** grants will provide critical support to state and local governments to ensure residential and commercial buildings save energy, reducing utility bills and carbon emissions.

States, tribes and territories have been working hard to set up these programs, which have also drawn strong interest from homeowners across the country. Repealing these programs and rescinding funding would not only limit consumer choice for energy upgrades, but would also disrupt the entire home performance industry, which has planned on the rollout of these rebate and workforce dollars since the IRA's enactment last August.
